**NO. SO (T-II) / 2 -17 / 2010:-** In exercise of the powers conferred by section 69 of the Provincial Motor Vehicle Ordinance, 1965, the Government of Sindh hereby makes the following amendment in the West Pakistan Motor Vehicles Rules, 1969.

**AMENDMENT**

In rule 2, after clause (f), the following shall be added:-

“(ff) Motor cycle rickshaw qingqi” means a motor vehicle with three wheels the unladen weight of which does not exceed 900 pounds avoirdupois, constructed, adapted or used for private purposes, other than for hire or reward, to carry not more than four persons excluding the driver on designated routes”.
