SUBJECT: - REPATRIATION OF 53 PROVINCIAL SERVICE EMPLOYEES TO THEIR RESPECTIVE PARENT ORGANIZATION

I am directed to refer to the subject noted above and to state that vide SGA&CD's Notifications of even number dated 25.02.2014, 06.03.2014 and 24.07.2014, 53 Provincial Service Employees were allowed to draw their salary through surplus pool of S&GAD. However, in pursuance of directives dated 15.08.2014 passed by the Honourable Supreme Court of Pakistan in Civil Petition No.694-K/2013 filed by Mehar Ali Dayo and with the approval of the Competent Authority i.e. Chief Minister Sindh, the above referred notifications have been cancelled / withdrawn vide Notification of even number dated 20.08.2014 (copy enclosed).

2. The Honourable Supreme Court of Pakistan vide above referred directives also directed that the parent Departments of the above referred employees should establish their own surplus pool in case the posts of the above referred employees have been abolished / filled or their lien has been terminated, the Administrative Departments should place the above referred employees in their own surplus pool till they get the vacant post or they may request the Finance Department to create the non cadre post corresponding to the Basic Pay Scale they were holding at the time of their absorption.

3. The Administrative Department should, however, ensure that these officers get their rightful seniority corresponding to their original positions in due course of time subject to fulfillment of all required codal formalities prescribed by their respective service rules.

4. Any officer aggrieved by this Notification is at liberty to approach the respective Court of Law after complying with this Notification.

5. I am therefore directed to advise you to kindly implement the above referred directives of the Honourable Supreme Court of Pakistan in letter and spirit and furnish compliance report to this Department.

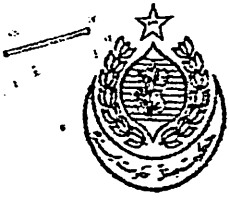
