NOTIFICATION

NO.SO(C-IV)SGA&CD/4-6/15: Under Karachi Transport Improvement Project (KTIP) and with the assistance of JICA, Government of Sindh has initiated infrastructure development of several Mass Transit Corridors in Karachi under its indigenous resources as well as through assistance from Government of Pakistan and development agencies. During currency of infrastructure development, it is considered by the Government of Sindh and highlighted by various stakeholders that parallel interventions by the appropriate provincial agencies are required for rehabilitation, land-use changes and for uplift of the areas that are to be catered by the respective Mass Transit corridors.

2. To bridge the above gap, the competent authority is pleased to constitute a Policy Recommendation and Implementation Committee to facilitate interventions due to development of Mass Transit corridors in Karachi. The Committee would comprise following members:-

3. The Committee may also co-opt any other person(s) for performing its functions.

4. Terms of Reference: The committee's functions include:-

- Assessment of adequate interventions in respect of rehabilitation, land-use changes and for uplift of the areas that are to be catered by the respective Mass Transit Corridors and for uplift the image of Karachi under existing and upcoming development interventions.
- The committee will ascertain the financial implications for next five (5) years and / or till the operationalization of all BRT Corridors.
- Interaction with different stakeholders including Provincial land Local Government agencies for their input and division of responsibilities.
- The committee will act as Complaint Rederassal Forum to address concerns of stakeholders during planning and implementation phase of the interventions.
- Collaborate with institutions and consultancies working on the parallel interventions in Mass Transit Corridors in determination of policy recommendation.
- Recommend extent of interventions by the respective provincial and local government agency, sponsoring mechanism and coordinate approval of the proposals.
- Upon approval of the funding, the Committee would oversee implementation of the interventions and consider adjustments within the same allocation by Planning & Development Department.
- The Committee would frame its preliminary recommendations in thirty (30) days upon notification. A detailed report, containing policy recommendations and implementation proposal(s), is required to be presented within ninety (90) days to the government for approval.
