Terms of References:

1. The Task force shall meet regularly on monthly basis however, the Chairman can convene urgent meetings, as required aimed towards the following objectives:
 - a) To immediately develop and monitor progress on the Karachi Action Plan for Polio Eradication.
 - b) To ensure adequate preparations for each and every campaign encompassing sound operational plans duly supplemented by requisite administrative and security arrangements through respective DPECs and Security Coordination Committees well in advance of planned campaign.
 - c) To ensure full functionality of DPCRs, through respective DCs, with all necessary equipment and human resource (Government and partners) as per NEAP guidelines.
 - d) To review progress of every campaign, to be presented by respective districts in consultation with EOC Sindh, and take necessary corrective actions as required.
 - e) To ensure strict accountability on the basis of performance and action against delinquent officials.
 - f) To present summary report to the Chief Secretary, Sindh for each campaign from December onwards.

3. The Chairman of the Task Force may co-opt any member for the Task Force, when required, to achieve the objectives of Polio Eradication in Karachi.


