- To verify that the contract appointment of the Contingent paid or work-charged employee of LBOD was made after observance of all codal formalities including advertisement of the post in the newspapers and minutes of the Selection Committee.
- That the Committee shall scrutinize whether the appointments were made by the respective Appointing Authorities as laid down in Rule-4(1) of the Sindh Civil Servants (Appointment, Promotion & Transfer) Rules, 1974.
- That the Committee shall scrutinize the performance of the Contingent paid or work-charged employee of LBOD has been satisfactory.
- To ensure that the principle of fair and equal opportunity is provided to all Contingent paid or work-charged employee of LBOD during the scrutiny process.
- To submit its recommendations to the Chief Minister, Sindh through the Finance Department, Government of Sindh within ninety (90) days for orders.
