SUBJECT: SUO MOTO CASE NO.20 OF 2016 – NON PAYMENT OF RETIREMENT BENEFITS BY THE RELEVANT DEPARTMENTS

I am directed to refer to the subject noted above and to inform that the Honourable Chief Justice of Pakistan has been pleased to take judicial notice of various complaints of the employees who have not been paid their pensionary benefits / dues and that notice to this effect has been issued to the Attorney General for Pakistan along with four Advocate Generals of the Provinces.

2. The Advocate General, Sindh, Karachi has desired that the circular be issued to the Heads of all the Departments not to delay in payment of pensionary benefits and further to collect information of any such case with reasons and expected that comprehensive report shall be forwarded to the office of the Advocate General, Sindh, so that his office shall be able to apprise the Honourable Court accordingly.

3. It, is, therefore, requested that directives / orders of the Honourable Chief Justice may kindly be implemented regarding not to delay in payment of pensionary benefits and comprehensive report in this regard may also be forwarded to the Advocate General, Sindh, Karachi for apprising the Honourable Court of the same.
