- iii) Detail of assets (Physical and liquid) and liabilities.
- iv) Technical and financial requirement for procurement, installation, commissioning, operation and maintenance of a modern Bus Assembly Plant.
- v) Outline proposal for development of the facility in PPP Mode.
- vi) The Committee may submit its report alongwith specific recommendations within a period of one month.
