- To advise the licensing authority to refuse to grant or renew a mineral permit.
- To advise the licensing authority to cancel a mineral title or mineral permit.
- To advise the licensing authority to amend the terms or conditions of any mineral title or mineral permit.
- To advise the licensing authority to invite competitive bids.
- To advise the licensing authority to grant a mineral title to a person as specified in Rule 8(2).
