 - v. Implementation of Special Economic Zone Act 2012.
 - vi. Approval of financial outlays.
 - vii. Oversight to ensure the enforcement of the zone rules, as per Special Economic Zone Act 2012.
 - viii. Monthly status reviews of project progress.
2. Committee will frame rules / by laws for the future constitution and working of the committee.
 3. Meeting of the Steering Committee will be held when called by the Chairman. The Secretary will prepare weekly and monthly status reports for distribution to the Steering Committee.
 4. A Board of Management would be constituted in accordance with Special Economic Zone Act 2012. The Board will serve in an advisory role to the Steering Committee during development.
