NO.SO(C-IV) SGA&CD/4-22/14: In partial modification of this department's notification of even number dated 24th September, 2014, the Government of Sindh is pleased to revise Terms of Reference of Technical and Financial Evaluation Committee (TFEC) to hire services of Education Management Organizations / Agencies (EMO) for providing management functions to schools under PPP mode as under;

- i. The Committee shall oversee selection process of private partner (EMOs);
- ii. The Committee may extend the date in respect of any activity of the Project Timeline in accordance with the provisions of Sindh Public Procurement Rules, 2010 (and as amended time to time);
- iii. The Committee shall review and approve the Bidding Documents such as evaluation (selection) criteria, Expression of Interest (EOI), Pre-Qualification Documents, Request for Proposal (RFP), Management Contract, Project Brief, Information Memorandum and any other document, for the purpose of issuing the same to the prospective bidders, by the Procuring Agency;
- iv. The Committee or its authorized representatives may, if the need be, hold pre-bid conference with the pre-qualified bidders, and address query of the bidder leading to finalization of the RFP and draft Management Contract;
- v. The Committee shall recommend the preferred bidder to the PPP Policy Board for signing of the Management Contract by the procuring agency under the PPP Act 2010;
- vi. The Committee shall perform any other task assigned to it by the PPP Policy Board in the context of EMOs. Moreover, the Committee shall be authorized to perform any task it deems appropriate to facilitate/ execution of the Management Contract(s), specific approval of which may not be required by the PPP Policy Board.;
