2. The incentive of award of higher grade (i.e. time scale) will be subject to the following conditions: -

- 1) The benefit of time scale will be considered and allowed on the recommendations of respective competent forum after scrutiny of service record / ACRs etc. instead of allowing by a simple notification / order.
- 2) Higher Grade will be considered as personal to the incumbent without allowing premature increment at the time of pay fixation in higher grade and the award of higher scale will not create any right to claim of higher post.




