

The Honourable Supreme Court of Pakistan has recently passed Judgement relating to the fundamental rights of minorities. In this regard, the Chief Secretary Sindh had recently convened a meeting to ensure implementation of the judgement by ensuring reserved quotas of minorities, women and disabled in recruitments with the direction that the reserve quota should be properly mentioned in all advertisements of recruitments published by each and every department/office of the provincial government.

2. In order to ensure fundamental rights of the minorities, women and the disabled, it is therefore requested to kindly ensure that the issue of reserved quota as mentioned above is strictly implemented by your department as well as by your subordinate offices. In future, the Information Department would strictly scrutinize all advertisements of recruitments with regard to mentioning of the reserve quota and would be constrained to accept any advertisement of recruitment in public service for publication that does not mention the same.

3. Hoping to have a positive riposte in this regard in the best public interest.


