Terms of Reference:-

1. To oversee the safety and security condition of the University and suggest minimum standards for each University separately.
2. Assess requirements for CCTV coverage in and around the University premises.
3. Set minimum standards for any emergency situation including but not limited to establishment of fire fighting system, rescue drill and Entry of emergency vehicles viz fire brigade / Ambulances in the premises.
4. Training of teaching staff and volunteer students to react in any untoward situation.
5. Employment / deployment of adequate armed security guard at entry / exist points and around the University.
6. Any other suggestions which committee may think appropriate.

The Committee shall visit all the public sector Universities of the Province and finalize / recommend suggestions within 15 days for each University keeping in view its size, location, number of students and vulnerability.
