**AMENDMENTS**

1. In Schedule-I, in serial No. 33, in columns 3 and 4, the following shall be deleted :-

**"(iv) Provincial Public Safety and Police Complaints Commission. (iv) Secretary, Provincial Public Safety and Police Complaints Commission".**

2. In Schedule-II -

i) under the heading "Services, General Administration & Coordination Department" the following entry shall be deleted:-

**23-A. "Provincial Public Safety and Police Complaints Commission for the purpose of budget and matters pertaining to the Provincial Assembly."**

ii) under the heading of "Home Department", the following entry shall be deleted :-

**"4-A. Power and Functions are provided in the Police Order, 2002".**
