NOTIFICATION

No.SORI(S&GAD)2-4/2013 (LAW/SGA&CD) :- In pursuance of the provisions of clause (3) of Article 139 of the Constitution of the Islamic Republic of Pakistan, 1973, the Government of Sindh are pleased to make the following amendments in the Sindh Government Rules of Business, 1986 :-

AMENDMENTS

In Part-VIII Legislation, in rule 45, for sub-rules (i), (ii) and (iii), the following shall be substituted :-

- i. "The Department administratively concerned shall determine the contents of the proposed legislation, consult the other Department, including Finance Department, if necessary, and refer it to the Law Department alongwith necessary papers which shall include a draft Bill together with Statement of Objects and Reasons and a self-contained note explaining the background and the provisions of the Bill.
- ii. When the proposed legislation is referred to the Law Department it shall be examined by the Law Department and if it is -
  - a) legally feasible, it shall be vetted and given legal shape;
  - b) legally not feasible, it shall be returned with such advice.
- iii. After the proposed legislation is vetted by the Law Department, it shall be sent to the department concerned to obtain approval of the Chief Minister for placing the same before the Cabinet."
