**TORs of the Special Committee:**

- (a) To scrutinize academic records (degrees/diploma certificates) and other relevant documents of the contract employee.
- (b) To verify that the appointment on contract basis of veterinary doctors in the Livestock & Fisheries Department in accordance with the provisions of the respective recruitment rules i.e. prescribing the age limit, academic/technical qualification and experience.
- (c) To verify that the contract appointment of the Veterinary Doctors of the Livestock & Fisheries Department was made after observance of all codal formalities including advertisement of the post in the newspapers and minutes of the Selection Committee.
- (d) That the Committee shall not recommend any Veterinary Doctor who was not appointed by the respective Appointing Authorities as laid down in Rule-4(1) of the Sindh Civil Servants (Appointment, Promotion & Transfer) Rules, 1974.
- (e) That the Committee shall not recommend the contract Veterinary Doctor whose performance has not been satisfactory.
- (f) To ensure that the principle of fair and equal opportunity has been provided to all contract Veterinary Doctors during the scrutiny process.
