- 3. Term of Reference/mandate of the Tripartite Consultation Committee shall be as follow:-
 - (i) To study and discuss the reports and comments of the International Labour Office communicated to the Government of Pakistan / Sindh.
 - (ii) To discuss and study the response to queries concerning agenda items of the International Labour Conference office pertaining to the Government of Pakistan / Sindh.
 - (iii) To monitor and review, as and when required, the Provincial Labour Laws / Rules / Regulation for ensuring its conformity, coherence and alignment with the International Labour Standard (ILS).
 - (iv) To study and discuss proposal concerning adoption of any new convention or recommendation of the ILO as enunciated in Article-19 of its constitution.
 - (v) To study un-ratified conventions and consider its recommendations for ratification or otherwise.
 - (vi) To study and discuss the proposal of the denunciation of any ratified convention.
 - (vii) Any other matter as and when assigned by the Government of Sindh.
- 4. The Committee shall meet at least twice a year. Presence of 50% of the total members (including one member each from the employers and workers and workers groups) will form the quorum for meeting.
