NO.P&D/MPA/CHIEF-TPP/1(2)/2010-11: With the approval of Competent Authority, Government of Sindh has been pleased to enhance the allocation of MPAs Priority Program from 20.00 Million to 40.00 Million each through merging the MPAs Extended Program during 2010-11.

The procedure and Criteria for the proposals of additional 20 Million will be same as already approved by the Cabinet for MPA Priority Program and the additional funds provided would be non-lapsable. It would be the discretion of the MPA to propose any scheme within approved criteria. It would be appreciated if all the MPAs in Sindh could propose scheme on urgent basis to utilize the allocated funds for the welfare of the people of their respective constituencies.
