I am directed to refer to the subject noted above and to state that the Honourable Supreme Court of Pakistan vide its order in the above subject case has directed all the Provinces to submit the following in consultation with the provincial departmental of Mines & Mineral Development Department, Environmental Protection Agency, Provincial Bureau of Statistics Labour and Human Resources Department and all notified Certifying Surgeons under Factories Act, 1934:

- (i) A monitor able time bound plan to collate the necessary base line data to effectively implement the Labour Laws specifically covering silicosis, other occupational Disease and Minimum Wages, alongwith No. of different types of employees, nature of work, health risk profiles, statistics of factories, shops and establishment.
- (ii) A comprehensive health monitoring and evaluation framework with medical inspection completion report alongwith plans for ensuring that workers are receiving health care that is adequate in terms of regular coverage and quality.
- (iii) A monitoring and evaluation framework, and a plan to automatic the same so as to ensure effective monitoring and evaluation of the implementation and enforcement of Labour and related rights and protection.

It is necessary to mention that Labour & Human Resources Department, Government of Sindh who is also nominated as Focal Department in this case,
