- i. To prepare a detailed policy for allotment of plots of the families of Shuhadas (Martyrs) of Armed Forces, Rangers Police, F.C. other law enforcing agencies and Government Servants martyred in the Province of Sindh.
- ii. Proposed policy may include the statement of conditions for the allotment to be issued under the Colonization of Government Lands Act, 1912 specifying eligibility and size of plots.
- iii. Identify suitable pieces of lands measuring 500 acres at Karachi and 100 acres at Ex-Divisional H.Qs excluding Karachi.
- iv. Recommend ways and means for Development of the identified pieces of lands.
