- Proposed policy may include the statement of conditions for the allotment to be issued under the Colonization of Government Lands Act, 1912 specifying eligibility and size of plots.
- Identify suitable pieces of lands measuring 500 acres at Karachi and 100 acres at Ex-Divisional H.Qs excluding Karachi.
- Recommend ways and means for Development of the identified pieces of lands.
