Terms of Reference

1. Approve the annual work plan and projects/proposals placed by the Competitiveness Support Fund.
2. Prepare plans to transform the Agriculture, Dairy, Livestock/ Fisheries, Special Economic Zones including industrial estates and other sectors into high value products under PPP.
3. Carry out feasibility studies action plan and projects preparation work to identify the potential of different sectors of the Sindh economy.
4. Provide support which may include matching enterprise grants, credits guarantee, technical assistance & infrastructure development to promote investment in different sectors in Sindh for value addition & job creation.
5. Undertake programs to reduce post-crop losses & to create necessary awareness about sanitary and phytosanitary practices to improve competitiveness of Sindh based products.
6. Oversee the implementation of different interventions through SDF and to make all decision pertaining to the sustainable use of funds intervention & coordination with other development partners to join SEDF.
7. Monitor the achievements of work of the fund.
8. The steering committee may co-opt any member/members.
