2. **ELIGIBILITY (MANDATORY):** Valid Registration with Pakistan Engineering Council and having Project Profile Code 1201, 1203, 1204 & 1210, Registration with Pakistan Council of Architects and Town Planners (PCAPT), Income Tax Registration, Sindh Revenue Board Registration, and the consultant must have registration with Securities & Exchange Commission of Pakistan (SECP), Security Clearance Certificate from Home Department and Work Experience with Security Establishment (**Mandatory**). The RFP documents include a detailed list of eligibility criteria and conditions.
3. **REP DOCUMENTS:** Applications are invited from interested National Firms according to Quality and Cost Based Selection QCBS Method (With an 80% Weightage for Technical and a 20% Weightage for Financial). The bid shall be received under Single Stage – Two Envelope Procedure as per SPPRA Rule-2010. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the "Financial Proposal" and "Technical Proposal". The Request for Proposal can be obtained by interested Consulting Firms from the address mentioned below. The request must clearly state "Request for RFP" as well as the name of the assignment. The RFP documents are available at fee of Rs. 3000/- (non-refundable) in form of cash.
4. **DEADLINE FOR ISSUANCE OF RFP DOCUMENTS:** RFP Documents will be issued to interested consulting firms on any working day beginning with the date of publication of the RFP Notice in Newspapers and continuing until **May 4, 2023, at 16:00 HRS**. 5. **DEADLINE FOR SUBMISSION:** Dully filled Technical and Financial Proposal and attached with relevant certificates must be delivered to address mentioned below at or before **14:00 HRS on 05-05-2023**. Initially, only the envelope marked as "Technical Proposal" shall be opened on same day at **14:30 HRS** in presence of representatives of participating firms, who may wish to be present. Only Technically Qualified firms shall be entertained for opening of Financial Bids. 6. **EVALUATION CRITERIA:**
  - a) Applications with required documents attached will be evaluated, and firms scoring 75% or higher will be considered for financial participation.
  - b) Applications of blacklisted firms shall not be considered.
  - c) The applicant will be disqualified if the Procuring Agency discovers, at any stage, that the information submitted for qualification was significantly inaccurate or incomplete.
7. **BID SECURITY:** 2.5% of the bid amount in shape of Call Deposit/ Pay Order/ Demand Draft from any scheduled Bank of Pakistan in favour of DIGP CTD Sindh, Karachi, should be submitted along with the financial proposal Otherwise, such a firm (s) will be rejected.
8. **BID VALIDITY:** 90-Days.
