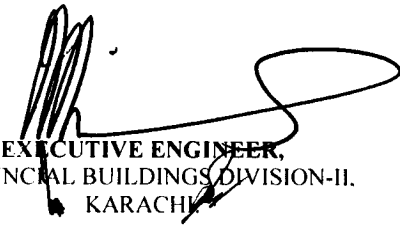
3- ELIGIBILITY / CONDITIONS:
