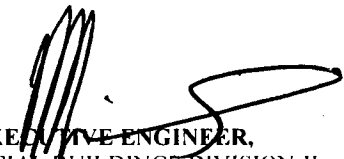
- Registration with Pakistan Engineering Council in the relevant category or above discipline (if applicable) keeping in view the bid costs.
