5. Agencies / firms should be registered with Sindh Revenue Board and Income Tax authorities and Pakistan Engineering Council.
6. The agency/contractor should have completed at least 03 Nos. works of similar nature in last three years.
7. Bank statement of the last three years showing annual financial turnover amounting to Rs.10 (M) per year.
