- v) Turn-over of at least three years for relevant amount works or more.

- vi) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- vii) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- viii) Affidavit to the effect that all documents / particulars / information furnished is true and correct.
