3. **Eligibility / Conditions:-**

- i) Active Registration with Pakistan Engineering Council in the C-4 category or above having specialized codes CE-01, CE-09, CE-10, EE-04, EE-05, EE-06, EE-07.
- ii) Active Registration with Income Tax Department and Sindh Revenue Board (SRB), (Copy of NTN, SRB Registration & CNIC must be attached).
- iii) Income Tax, Sales Tax, SRB Tax or any other Tax levied by Government at any time will be deducted from successful bidder as per rules.
- iv) The Earnest money @5% of bid cost shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned. The tenders without earnest money will not be entertained.
- v) Experience in similar nature of work(s) executed during the last five years
