TENDER NOTICE

Sealed tenders are invited from the Manufactures / Suppliers as well as from the importers of store items in the name of Secretary Food/Procurement Agency, Government of Sindh, Food Department, Karachi for supply of Polypropylene Bags according to the Sindh Public Procurement Rules, 2010 (Amended upto-date) for the year 2022-23 as per description below:-

SPECIFICATION OF STORE ITEMS.

POLYPROPYLENE BAGS. No. SO (W)-13(17)/ 2022-23/Bardana

	Quantity required	Delivery Period
Tubular woven P.P Bags manufactured from prime virgin material with hemmed bottom and heat cut mouth ends. Made of ultra violet stabilized polypropylene for packing of wheat. In both the cases, the contents of UV stabilizer should not be less than 0.35%. <u>Size:</u> Outside Width: 59 cm (23")$\pm$ 1.5 cm/0.5" Outside Length: 100 cm (39")$\pm$ 1.5 cm/0.5" Tape: Diner, 1000 material UV stabilized polypropylene OR UV stabilized mixed polypropylene. <u>Weave:</u> 11 tape X 11 tap per inch. <u>Weight:</u> 115 grams $\pm$ 5% <u>Capacity:</u> 50 kg for wheat grains. <u>Colour:</u> Transparent. <u>Bottom Seam:</u> the Bottom of the bag should be folded once at sewn. The width of fold should be 2.54 cm (1 inch) <u>Stitching:</u> Acid resistant thread of Nylon or polypropylene of 1000 denier should be used. Chain stitch should be used for sewing with at least 4 stitches per inch. The stitching should be uniformed <u>without any loose thread.</u> <u>Drop Strength:</u> The bags filled with 50 Kg wheat should be adequate to withstand without bursting at least 6 drops from a height of 16 feet when dropped flat. <u>Printing:</u> Printing design as approved will be printed on one side of the bag in red colour. <u>Packing:</u> 1000 bags in one bale wrapped in new polypropylene woven fabrics. <u>UV Stabilizer:</u> $\geq$ 0.35%	20,000 Bales (1000 bags in eachbale)	30% by 06th March, 2023 or earlier and 70% within 45days from the date of Contract or earlier.

Special Conditions.

1. Each bag should bear stenciled mark as “**SINDH FOOD-2022-23 SCHEME**”, with two Royal blue strips of one inch each to run lengthwise on right corner of bag starting from front top of bag upto back top of bag alongwith initials **OR** name of the supplying firm.

N.B: However, the quantity of Region-wise bardana (Bags) may vary.

GENERAL CONDITIONS FOR ABOVE STORES.

- (i) Tender documents containing technical and financial evaluation criteria are available on SPPRA website. Relevant technical evaluation criteria for all store items is annexed separately with respective bidding documents.
- (ii) Tenders shall be submitted (in duplicate) on the prescribed form as per conditions of tender enquiry. Tender forms/bidding documents alongwith technical evaluation criteria form will be available in the office of Section Officer (Wheat), Food Department, from the date of publishing of this advertisement and can be obtained on payment of **Rs. 2000/-** (Non-refundable) for each tender to the Cashier of Food Department/State Bank of Pakistan.
- (iii) The bids shall be submitted as per “Single Stage – Two Envelope Procedure” under rule 46(2) of the Sindh Public Procurement Rules, 2010, i.e. a single package consisting of two separate envelopes containing Technical and the Financial proposals separately.
- (iv) The contract as a whole shall be governed by the terms and conditions laid down in the Sindh Public Procurement Act 2009 and the Sindh Public Procurement Rules, 2010 (amended upto date). The tenders not submitted as per specification, shall not be considered.
- (v) The bidders are required to submit **earnest money/bid security at the rate of 5%** of the amount of their offer in the shape of Pay order / Call Deposit/ Bank Draft in favour of Secretary Food, Government of Sindh/ Procuring Agency. Tenders not supported by earnest money/bid security will not be entertained. However, the earnest money/bid security shall be returned to the unsuccessful bidders after awarding of Contract to the successful bidder(s). The earnest money/bid security will be refunded to the bidders after placing order with the successful bidders. 15% variation of quantity can be observed at same price.
- (vi) The payment of carriage / un-loading / stacking charges at consignee’s end will be the responsibility of the supplier.
- (vii) Each page of the tender documents i.e tender form will be signed/ stamped by the tenderer.
- (viii) All the bids should be submitted alongwith five samples of store items otherwise the offer will not be considered.
- (ix) The samples shall be sent to any designated laboratory/ institute, notified by the Government / Department for the purpose. Samples technically approved by such lab/ institute shall be considered for next stage.
- (x) Bid offer will be valid for 60-days from the date of opening of tenders. The participating firms of stores items i.e. P.P Bags shall offer minimum 30% of total quantity of the PP Bags (i.e. 20,000 bales).

- (xi) The participating firm must be registered with the Sales Tax and Income Tax Departments. Provision of proof of registration of bidder/firm with relevant government department / agency i.e. SECP/Registrar of Firm etc. In case of International Tenders, Registration Certificates in their respective country of origin be attached.
- (xii) The rates offered will be inclusive of all taxes leviable under the law quote.
- (xiii) In case of International goods tenderers/ importers, they will have to quote their rates in Pakistani Currency.
- (xiv) The successful tenderer is required to furnish **5% performance security** of the cash value of offered quantity deposited in the form of Call Deposit in favour of Secretary Food Sindh, within the period specified in Advance Acceptance of Tender (AAT), failing which his earnest money/bid security may be forfeited and repurchase shall be made at his risk and cost.
- (xv) The bidder must possess minimum five years' experience of manufacturing / supplying similar stores (PP Bags).
- (xvi) The bidders shall submit proof of production capacity, previous supplies and sales tax returns.
- (xvii) Tenders will be opened by the Evaluation Committee in the Committee Room of Food Department, 4th Floor, New Sindh Secretariat Building No.1, in the presence of tenderers or their authorized representatives.
- (xviii) The Evaluation Committee shall evaluate the Bidding documents /Technical proposals, without reference to the price and shall reject any proposal which does not conform to the requirements as specified in the Tender Enquiry Form.
- (xix) Notwithstanding anything to the contrary, Secretary Food/ Procuring Agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal according to SPPR Rules-2010 and shall not incur any liability towards the bidders.
- (xx) The successful bidder shall be liable to affix adhesive stamps on the Contract/Agreement at 0.35% of the value of Contract/Agreement in accordance with the terms of Stamp Act 1899.
- (xxi) In case of failure on the part of the parties to perform their obligations under the Contract, they will not be considered at the default if such failure is the result of an event of force majeure as defined in the conditions of Contract as per Clause-Rule 40 of SPPR Rules-2010.
- (xxii) The date of receipt of tender form will start from the date of publication of tender notice under the Provisions of SPPR Rules-2010. Last date for submission and opening of tenders is given below:-
