2. ELIGIBILITY / MANDATORY

- xiii. Valid Registration Certificate upto June-2022 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against each work.
- xiv. At least 03 works of same specification and nature having equal or more cost **OR** quantum (in terms of quantities) completed during past three years duly supported with completion certificate, certified copies of Detailed Working Estimate and SPPRA ID's showing Bid Evaluation Report.
- xv. Bio-Data of Engineering and Technical Staff working with the firm.
- xvi. Annual turnover of at-least per annum to the estimated cost of the work applied, in last 03 years. (turnover will be evaluated from annual returns and Audit Reports).
- xvii. Annual audited reports of last three years from (ICAP) registered audited firm. Audit report issued other than (ICAP) registered audit firms will not be accepted.
- xviii. List of machinery and equipment available with documentary evidence of its ownership / rented.
- xix. Certificate of bank showing credit worthiness at least 15% (average balance per year for the last 3 years) of the estimated cost of work along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for last three years and recent bank certificate must be attached showing available balance.
- xx. Professional Tax Payer.
- xxi. Registration with Income Tax Department (NTN Certificate) with active status with Federal Board of Revenue.
- xxii. Annual Income Tax Returns of Last three years.
- xxiii. Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) Certificate (with Active Status).
- xxiv. Each page of the technical proposal must be numbered and attested by the owner of firm / company along-with its stamp.

3. Method of Procurement (Single Stage Two Envelopes)**4. Bidding / Tender Documents**

- 16. Contract documents and other terms and conditions can be seen or downloaded from the official website of SPPRA i.e "e.pprasindh.gov.pk". The tenders amount to PK Rs.5,000/= and the bid security mentioned above **in the shape of Call Deposit only from any scheduled bank of Pakistan in Executive Engineer Provincial Highways Division Larkano on account of (Name of firm)**, should be attached with the Bid / Tenders, otherwise such tenders will not be entertained.
- 17. Manner of Bid Security other than CD-R will not be accepted.
- 18. Evaluation Criteria, sub-criteria, for the evaluation of Full Technical Proposals is based on **Yes / No OR Pass / Fail**; if a bidder fails to obtain yes or pass in any criteria or sub- criteria then he / it shall not be qualified.
- 19. The tender will be opened in the presence of Procurement Committee / participating contractors / firms and their authorized representatives, who may wish to be present.
- 20. Bid shall comprise **Single Package containing two separate envelops**. Each envelop contain separately the **Financial Proposal** and the **Technical Proposal**. Envelope shall be marked Technical proposal and Financial Proposal in bold and legible letters to avoid confusion.
- 21. **TECHNICAL PROPOSAL** opened, shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bids / proposals of technical non shall be returned to the respective bidders un-opened.
- 22. The CD-R's of the technically responsive bidders but reject due to higher rate will be returned back after the issuance of work order to the successful bidder.
- 23. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening bids will be submitted and opened on next working day on same schedule.
- 24. Joint Venture will not be allowed.
- 25. Fresh affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus / Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.

28. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work.
29. Fresh affidavit to this effect that the Firm / Contractor have not been black listed previously by any executing agency.
30. In case of Public Holiday / Strike or due to any untowards incident, the date of submission / opening will be the next working day with same schedule.

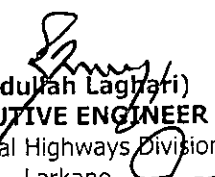
