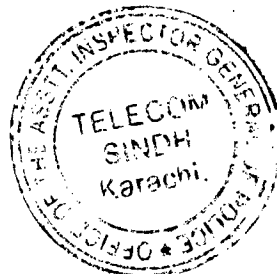

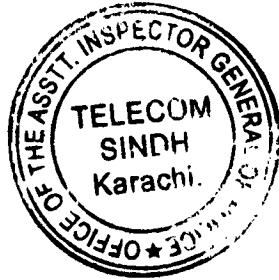
- i. Contractor / Contracting firm should be registered with (FBR) Income Tax and Sindh Revenue Board (NTN, STN & SRB registration certificates with renewal will be required).
- ii. Contractor / Contracting firm are advised to quote rates on Unit/Job/Per Sft/Rft/ basis
- iii. Payment shall be made for the works on basis of job, unit basis (as the case may be) on completion for each item/work based on measurement & verification in accordance with specifications / schedule "A"
- iv. The work calculation / RCE may vary by (+) or (-) 5%.
- v. The Contractor/contracting firm will be required to show evidence of experience capability in respect of personnel / machinery, financial / position etc. (Profile of the firm).
- vi. Any contractor / contracting firm blacklisted by Government Department or Agency will not be allowed to participate in tender / bid (Participating contractor / contracting firm will be required to submit affidavit to the effect that they are not blacklisted by any Government Department).
- vii. Contractor will be required to provide copy of CNIC and contracting firm will be required to provide certificate of registration.
- viii. Only the bid offered on the prescribed tender form issued by the department shall be accepted. However, additional sheets can be attached if required.
- ix. Conditional tender shall not be entertained
- x. Validity of bid / offer shall be at least 90 days from the date of opening of tender
- xi. The competent authority reserves the right to reject all or any bid in accordance with Sindh Public Procurement Rules 2010 (Amended up to date) and conditions contained in tender documents.

Complete set of bidding documents containing the scope of work and relevant details along with specification can be obtained by the interested contractor / contracting firm from office of the Assistant Inspector General of Police, Telecommunication Sindh at Police Headquarters South Garden Road Karachi during working hours up to last date of submission of bids on payment of Tender Fee (non-refundable) Method of Procurement will be **SINGLE STAGE ONE ENVELOPE**.

Tenders / Bids (dully sealed along with earnest money @2.5% of offered bid) shall be dropped in the tender box placed in the office of Deputy Inspector General of police Technical & Transport Sindh, 4th Floor, Central Police Office, I.I Chundrigar Road Karachi on or before as last date 15/03/2023 up to 1430 hrs. Bids shall be opened by Departmental Procurement Committee on same day i.e. 15/03/2023 at same place i.e. office of Deputy Inspector General of Police Technical & Transport Sindh, 4th Floor Central Police Office I.I Chundrigar Road Karachi at 1500 hrs in presence of duly authorized representatives participating Contractors/Contracting firms
3. Any other information relating to this Tender/Bid or detail of work or any further clarification can be obtained from the office of the Assistant Inspector General of police, Telecommunication Sindh, Police Headquarter South Garden Karachi during office hours before opening of tender.
4. The contractors/contracting firms are advised to fully understand scope of works and quality / quantities. They may also visit the site to assess themselves any additional incidental availability of electricity, water or any other item) which may come up before or during execution of the work of this tender because no cost will bear by Police Department for such eventualities nor any extension in time will be provided on such pretext
5. The work will commence after the approval of competent Authority and subject to availability of funds.
