NOTICE INVITING TENDER

The Government of Sindh, intends to invite tenders for the following work under the **ADP Scheme No. 2009** namely “**Establishment of Jetties in District Badin and Sujawal**”. The Director General Fisheries Sindh, Marine & Coastal Fisheries Development - Karachi for the years 2023-2024 & 2024-2025 as purchaser invites sealed tenders from eligible contractors registered with Pakistan Engineering Council in relevant Category or above with Code CE-03, CE-05 & CE-10, Sindh Revenue Board, Income Tax, Sales Tax Department and are on active taxpayers list of Federal Board of Revenue (FBR) for the following Work;

- 1) Bids shall be accepted under the “Single Stage two envelop procedure” defined in the rule 46(2) of Sindh Public Procurement Rule 2010, according to which the bid shall comprise a single package containing two separate envelop Each envelope shall contain separately the Technical and Financial Proposal. Each envelops shall be marked in BOLD and eligible letters to avoid confusion. Initially envelop marked “**TECHNICAL PROPOSAL**” shall be opened. The envelope marked as FINANCIAL PROPOSAL shall be retained in the custody of the purchaser without being opened. The Financial proposal of the technically qualified bids only shall be opened at the date, time and place communicated to the bidder in advance. Further details are in the tender documents.
- 2) Tenders must be accompanied by a Bid Security of 2.5 % by registered firms (refundable) of the value of tender in shape of pay order / bank draft in favor of the Director General Fisheries Sindh, Marine & Coastal Fisheries Development - Karachi which shall remain valid for a period of 28 days beyond the Bid validity date, along with tender bond, photocopy of Computerized National Identity Card and National Tax Number.
- 3) Rates must be quoted including all Government Taxes.
- 4) Rates quoted for tender item must be valid till 60 days with effect from the date of opening of tenders.
- 5) Application are therefore invited from reputed floating jetties manufacturer / builders / constructors / installers or their authorized agent in Pakistan having adequate experience in

the relevant works in similar geographic condition in Pakistan for following scope of work(s) and meeting the criteria under Sindh Public Procurement Rules 2010 (Amended 2019).

- 6) The interested parties with adequate experience / expertise in similar geographic condition in Pakistan may participate in the tenders by offering their bid for “**Establishment of jetties in District Badin and Sujawal**” made of High Density Polyethylene having 100 % Ultra Violet Rays UVA and UVB resistance, HDPE Fenders, sea based / offshore piling, Stainless Steel Gangway or walkway & Community Shed.
- 7) Interested firm shall submit following information substantiated with documentary evidence.
 - a. Company profile
 - b. Registration with Income Tax, Sales Tax & Sindh Revenue Board (SRB).
 - c. Valid Registration with Pakistan Engineering Council in relevant Category with Engineering Codes CE-03, CE-05 & CE-10.
 - d. Product should be approved from Environment Protection Agency, Sindh.
 - e. Financial Status of last three years / certificate from bankers
 - f. Reference of Similar works in Pakistan along with execution certificate (Documentary evidence is required - Work Order & Completion Certificate).
 - g. Relevant experience in same geographical locations with proven track record (Documentary evidence is required - Work Order & Completion Certificate).
 - h. List of technical manpower / consultants on their payroll with relevant field experience for the execution of works.
 - i. A certificate to the effect that firm has never been black listed or in litigation.
 - j. Affidavit to the effect that all documents / particulars / information furnished are true and correct, if any information found incorrect / misleading, the purchaser reserves the right to reject the bid.
- 8) Purchase will be made as per provision under the Sindh Public Procurement Rules 2010 (Amended 2019).
- 9) Supply order / contract will be issued subject to the availability of funds.
- 10) Breakage / leakage during transport is the responsibility of Contractor.
- 11) The Procuring Agency reserves the right to reject all or any bid under SPPRA Rule 2010 (As amended from time to time).
- 12) A complete set of tender documents can be purchased on payment of tender fee up to **15-04-2024** (during office hours) on submission of a written application on the company's letter head with non-refundable fee of Rs.2000/- in the shape of pay order / bank draft in favor of Director General Fisheries Sindh, Marine & Coastal Fisheries Development, Poultry Research Institute Opposite Bagh-e- Korangi, Karachi.

- 13) The Bid offers accompanied with full information (specification sheets) of the product / equipment and separate for every part / item should be submitted in the Directorate General Fisheries Sindh, Marine & Coastal Fisheries Development- Poultry Research Institute Opposite Bagh-e- Korangi, Karachi on 16-4-2024 by 11:30 AM.
- 14) The bids shall be opened on same day on 16-04-2024 at 12:00 AM by the Committee in the presence of Bidders or their authorized representatives at Directorate General Fisheries Sindh, Marine & Coastal Fisheries Development, Poultry Research Institute Opposite Bagh-e- Korangi, Karachi.
- 15) The job is required to be completed before 30th June 2025.
- 16) Interested eligible contractors / firms may obtain further detailed information regarding tender item from the office of Directorate General Fisheries Sindh, Marine & Coastal Fisheries Development, Poultry Research Institute Opposite Bagh-e-Korangi, Karachi

Terms & Conditions:

- a) The Bidder Agencies / Firms should be registered with Sindh Revenue Board and Income Tax Authorities.
- b) The Bidder Agencies/Firms /Contractors should have completed at least 05 number of works of similar nature in the last five years & have four years experience in Floating Jetties.
- c) Bank Statement / audit report / other documents of last three years showing annual financial turn over per year of the firm / contractor.
- d) The intending contractor should submit an affidavit to the effect that the firm / contractor is not involved in any litigation & has not abandoned any work in any Govt. Department and is not black listed.
- e) Separate financial proposal be submitted for each category as above.
- f) Purchase / Supply order will be issued on availability of allocated fund
