1. Contractor / Contracting firm should be registered with Federal Board of Revenue and Sindh Revenue Board.
2. Contractor / Contracting firm are advised to quote rates on Unit/Job/Per Sft/Rft/ basis. Any correction overwriting in quoted price shall be valid reason to reject proposal.
3. Any offer valued over Rs. 1.25 million shall not be accepted.
4. Payment shall be made for the works on basis of job, unit basis (as the case may be) on completion for each item/work based on measurement & verification in accordance with specifications / schedule "B"
5. The work calculation / RCE may vary by (+) or (-) 5%.
6. Contractor/contracting firm will be required to show evidence of experience capability in respect of personnel / machinery, financial / position etc. (Profile of the firm).
7. Any contractor / contracting firm blacklisted by Government Department or Agency will not be allowed to participate in tender / bid. The participating contractor / firm will have to submit an affidavit that they are not blacklisted by any of the Government Department / Agency.
8. The Contractor (s) will have to provide a copy of CNIC and the contracting firm will have to provide a certificate of registration.
9. Only the bid offered on the prescribed tender form issued by the department shall be accepted. However, additional sheets can be attached if required.
10. Validity of bid / offer shall be at least 90 days from the date of opening of tender
11. The competent authority reserves the right to reject all or any bid in accordance with Sindh Public Procurement Rules 2010 (Amended up to date) and conditions contained in tender documents.

INFORMATION AND PROCEDURE

1. Complete set of bidding documents containing the scope of work and relevant details along with specification can be obtained by the interested contractor / contracting firm from office of the Assistant Inspector General of Police, Telecommunication Sindh at Police Headquarters South Garden Road Karachi during working hours up to last date of submission of bids after payment of Tender Documents Fee (non-refundable). Method of Procurement will be **SINGLE STAGE ONE ENVELOPE**.
2. Tenders / Bids (dully sealed along with earnest money @ 2 % of offered bid) shall be dropped in the tender box placed in the office of **Deputy Inspector General of police Technical & Transport Sindh, 4th Floor, Central Police Office, I.I Chundrigar Road Karachi** on or before 1st April 2024 up to 1430 hours.
3. Bids shall be opened by Departmental Procurement Committee on same day i.e. 1st April 2024 at 1500 hours in the office of the **Deputy Inspector General of Police Technical & Transport Sindh, 4th Floor Central Police Office I.I Chundrigar Road Karachi** in presence of duly authorized representatives participating Contractors/Contracting firms.
4. Any other information relating to this Tender/Bid or detail of work or any further clarification can be obtained from the office of the **Assistant Inspector General of police, Telecommunication Sindh, Police Headquarter South Garden Karachi** during office hours before opening of tender.
5. The contractors/contracting firms are advised to fully understand scope of works and quality / quantities. They may also visit the site to assess themselves any additional incidental availability of electricity, water or any other item) which may come up before or during execution of the work of this tender because no cost will bear by Police Department for such eventualities nor any extension in time will be provided on such pretext.
6. The work will commence after the approval of competent Authority and subject to availability of funds.
