TERMS AND CONDITIONS

01. Single Stage-Two Envelopes Procedure will be adopted. Each envelope shall be separately marked as "Technical Bid & Financial Bid".
02. Tenders are required to be furnished with earnest money of 2.5% of total value of bid from scheduled bank in Pakistan in favor of Sindh Poultry Vaccine Centre, Karachi.
03. Partial and incomplete bids will not be considered. Bids received after prescribed date and time will be rejected. If the opening date is declared as holiday then the tender will be opened on next working day at same time.
04. The envelope of "Financial Bid" of only "Technical Qualified Firms" will be opened in presence of their respective representatives at the date and time to be determined and communicated later.
