TERMS & CONDITIONS

1. Single stage one envelope procedure will be adopted for the tender process. Each bid shall comprise one single envelope containing the financial proposal and required information mentioned in Evaluation Criteria of bidding documents.
2. Interested suppliers / firms may obtain the tender document for the supply of Dietary Food items for the trainees Mess of SCTC Sakrand by submitting an application on their letterhead along with tender fee of Rs.3000/- from 15.09.2023 to 05.10.2023.
3. Sealed tenders on prescribed proforma in duplicated along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/C) in favour of Commandant, SCTC Sakrand should be dropped in the Tender Box kept in the office of the Specialized Commando Training Centre Sakrand @ Nasri on 05.10.2023 at 1300 hours.
4. The tender shall be opened on 05.10.2023 at 1330 hrs in the presence of Procurement Committee and representatives of bidders who choose to be present on the occasion in the office of the Meeting room SCTC Sakrand.
5. Only suppliers firms registered with FBR for Sales Tax & SRB Income Tax, other related taxes are eligible to participate in the tender (Documentary proof required).
6. All items should be hygienic and quality-wise samples may also be provided.
7. Only bid offered on the prescribed tender form issued by the Police Department will be accepted. However, additional sheets may be attached, if required.
8. Conditional tenders / applications will not be entertained.
9. Competent Authority can cancel the bidding process at any time prior to the acceptance of proposal as per provision of Rule-25(1) of SPPRA Rules-2010 (Amended-2019).
