TERMS & CONDITIONS

1. Single stage one envelope procedure will be adopted for the tender process. Each bid shall comprise one single envelope containing the financial proposal and required information mentioned in Evaluation Criteria of bidding documents.
2. Interested suppliers / firms may obtain the tender document for the supply of Dietary Food items for the trainees Mess of RTC, Jam Nawaz Ali at the rate of Rs. 5000/- per Trainee including all relevant taxes of FBR & SRB Taxes. Submitting an application on their letterhead along with tender fee of Rs.5000/- from 25.09.2023 to 16.10.2023.
3. Sealed tenders on prescribed performa in duplicated (Repeat in duplicate) along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/C) in favour of Principal, RTC, Jam Nawaz Ali should be dropped in the Tender Box kept in the office of the Principal Police Recruits Training Centre RTC, Jam Nawaz Ali on 16.10.2023 at 1300 hours.
4. The tender will be opened on 16.10.2023 at 1400 hrs in the presence of Procurement Committee Members and representatives of bidders who choose to be present on the occasion in the office of the Principal RTC, Jam Nawaz Ali.
5. Only suppliers firms registered with FBR for Sales Tax, SRB Income Tax & other related taxes are eligible to participate in the tender (Documentary proof required).
6. The Contractors should submit the Affidavit to effect whether he is not involved in any litigation or absconded the work in any Govt: Department and also not black listed.
7. All Food items should be hygienic and quality-wise samples may also be provided.
8. Bids offered only on the prescribed tender form issued by the Police Department will be accepted. However, additional sheets may be attached, if required.
9. Conditional tenders / applications will not be entertained.
10. Competent Authority can cancel the bidding process at any time prior to the acceptance of proposal as per provision of Rule-25(1) of SPPRA Rules-2010 (Amended-2019).
