Bid Submission Deadline: Sealed bidding documents comprising Technical and Financial proposals in separate sealed envelopes with clear marking of "Technical Proposal" and "Financial Proposal" of above skill development programs in duplicate along with 2.5% earnest money of the quoted amount of the total bid in the form of Pay Order / Demand Draft should be dropped / submitted at the office of the Section Officer (G), 1st Floor, Sindh Secretariat No. 6, Karachi (021-99213827-99213406) on or before Wednesday 19th October, 2022 at 2.00 pm. Further information / clarification may also be obtained in the same office.

Bid Opening: Technical Proposals of the participating bidders will be opened in the same day i.e Wednesday 19th October, 2022 at 2.45 pm in presence of the Consultant Selection Committee (CSC) Committee and intending bidders or their authorized representatives. In case the bids could not be opened on the above stated date, the same would be opened on next working day at the same time.

Financial Bids Opening: Financial bids of only technically qualified bidders shall be opened as per Rule-71(1) of SPPRA Rules, 2010 (Updated 2022)
