### INVITATION FOR PREQUALIFICATION OF MANUFACTURERS & IMPORTERS FOR PROCUREMENT OF VETERINARY MEDICINES, VACCINES (IMPORTED), INSTRUMENTS EQUIPMENT (HOSPITAL TOOLS) ETC. DURING C.F.Y. 2021-22

The Government of Sindh Livestock & Fisheries Department, intends to procure Veterinary Medicines, Vaccines, Instrument, equipments (hospital tools) etc in bulk quantities for its field Institutions during current financial year 2021-22.

Manufacturers and Importers of veterinary medicines, vaccines (imported), Instrument, equipments (hospital tools) will be prequalified according to the provisions of SPPRA Rules, 2010 amended 2019 Rule 27(2) to ensure transparency, competitiveness and efficiency in the procurement process. Applications for prequalification are invited from well-reputed, financially sound, income tax /sales tax / SST registered manufacturers / importers having experience in the field of veterinary medicines, vaccine, Instrument, equipments (hospital tools).

The applications must accompany the following information/documents:

1. Name of Firm with year of establishment and full address, telephone number of person duly authorized by the Firm for correspondence.
2. Proof of experience of supply of medicines, vaccine, Instrument, equipments (hospital tools) etc with details, executed since last three years.
3. Valid Proof of registration with the Competent Authority, DRAP.
4. Valid Proof of current good manufacturing practices (cGMP).
5. Valid Manufacturing / Import Licenses from the Competent Authority, DRAP.
6. Valid certificate from Securities and Exchange Commission of Pakistan (SECP).
7. In case of importer:
  - a. Valid proof of production from original source alongwith contact details for confirmation.
  - b. Valid proof of authorization from original source alongwith contact details for confirmation.
8. In case of Herbal Drugs manufacturer / chemical repacking firm must provide Certificate from DRAP.
9. Details of financial management and technical staff.

10. List of equipment and machinery owned by the firm along with ownership documents.
11. Financial statement issued by scheduled Banks in the name of Firm for last three years.
12. Audit reports for last three years.
13. Proof of present assets owned and held by the Firm.
14. Detail of any arbitration / litigation or similar proceedings against any Govt. / Semi- Govt. Department/Organization (if any).
15. Undertaking on judicial paper that the Firm was never black listed by any of the Government / Semi Govt. Department/ Organization in the past.
16. Registration with FBR/SRB along with a certificate of payment of income tax / sales tax for last three years and a copy of Active Tax-payer List (ATL).
17. Detail of production / import capacity of various medicines / items of the Firm.
18. In case of a Company, Limited Firm, Partnership Deed, Article of Association with power of attorney, if any.

**Rules:**

The Firm is required to give undertaking that it has carefully studied the prequalification document and it will abide by the rules and regulations.

Any concealment about the information mentioned above will result in disqualification of the Firm.

In case of incomplete information, the application will not be considered for prequalification.

The decision of prequalification committee will be final.

Only prequalified Firms will be eligible to participate in the subsequent procurement process.
