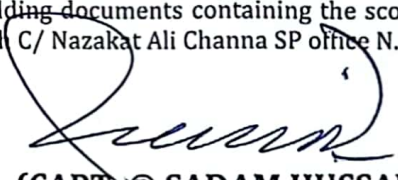

The tender fee amount Rs: 5000/- and the bid security is 5% in the shape of call deposit only from any scheduled bank of Pakistan on account of Superintendent of Police, Naushahro Feroze should be attached with Bidding documents, otherwise such tender will not be entertained.
- The intending contractors should submit the affidavit to affect whether he is not involved in any litigation and not abandoned the work in any Government Department and has not black listed.
- The intending participants must be registered with PEC, for the year 2024-2025.

- Agencies / Firms should be registered with Sindh Revenue Board, Income Tax & NTN
