**INSTRUCTIONS.**

1. Single Stage Two envelope procedure will be adopted for the tender process. Bid shall comprise of a single **package** containing two separate envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as **“FINANCIAL PROPOSAL”** and **“TECHNICAL PROPOSAL”** in bold and legible letters to avoid confusion.

2. Interested suppliers, authorized dealers & well reputed firms may obtain the tender document along with tender fee Rs. 3000/- for the supply of above Furniture items from the office of the DIGP/CTD Sindh, Karachi, by submitting an application on their letter head along with tender fee from the date of publication of the tender upto 11.04.2018, 1100 hours and may contact to Mr. Asif Ahmed Khan (Accountant) DIGP/CTD Office, old Circuit House near Qasar-e-Naz Club Road, Karachi, office No.021-99203427, or Email at [acc.digpctd@gmail.com](mailto:acc.digpctd@gmail.com) during working hours on working days.

3. Sealed tenders on prescribed proforma in duplicate along with 2.5% earnest money *of the* total bid in the form of Pay Order (Payee's A/c in favor of DIGP/CTD Sindh, Karachi) should be dropped in the tender box kept in the office of the DIGP/CTD Sindh, Karachi, (Old Circuit House Near Qasar-e-Naz Club Road, Karachi) on or before 11.04.2018 at 1300 hours.
4. The tender shall be opened on 11.04.2018 at 1330 hours in presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion, in the DIGP/CTD room (Old Circuit House Near Qasar-e-Naz Club Road, Karachi)
5. The successful bidder will have to deposit **10% security** of the amount of contract, in the form of pay order, bank guarantee or any other financial instrument recognized by Government of Pakistan, to the satisfaction of DIGP (CTD). The same will be returned on due completion of the contract and warranty period.
6. Only Manufactures, Suppliers, Authorized dealers and well reputed firms registered with FBR, SRB for Sales Tax Income Tax & other related Taxes are eligible to participate in the tenders (Documentary proof required).
7. Only bids offered on the prescribed tender form issued by the Department shall be accepted however, additional sheets may be attached, if required.
8. Conditional tender / application will not be entertained.
9. Counter Terrorism Department (CTD) reserves the right to increase or decrease the quantity of items as per SPPRA Rules.
10. Competent authority can cancel the bidding process at any time prior to acceptance of a proposal as per provision of Rules-25(1) of SPP Rules 2010 (amended 2017)
