Bid will be “Post Qualified” on the basis of Information provided with the Bid. Bidder(s) who fail to qualify in this respect shall not be considered.



Pre-Bid meeting will be held on 11/11/2011 in the Conference room on 2nd floor of Medical Superintendent Office, Civil Hospital Karachi.

Two Envelope Bid Return System will be adopted. One envelope containing information regarding Post Qualification of the Bidders shall be clearly marked “TECHNICAL QUALIFICATION INFORMATION”. The second envelope containing the Priced Bidding & Contract Documents shall be clearly marked “FINANCIAL BID DOCUMENTS”.

“FINANCIAL BID DOCUMENTS” shall be accompanied by Earnest Money/Bid security in the form of bank guarantee, bank draft/ pay order or Insurance guarantee drawn in favour of “Medical Superintendent, Civil Hospital Karachi”. “Technical Qualification Information Document” shall be accompanied by the proof (copy) of Earnest Money/ Bid security.

8. Partial & incomplete bids will not be considered. Technical Qualification Information and Financial Bid Documents (both envelopes) are to be submitted at the under mentioned address by 21/11/2011 at 1130am. The envelope containing Technical Qualification Information shall be opened on the same date at 1200hrs in the presence of those bidders who wish to attend. Bids received after the prescribed time and date shall be rejected.
9. The Financial Bid Documents of the Bidders who fail to Post Qualify shall be returned to them unopened. The Decision of Medical Superintendent, Civil Hospital Karachi in this connection shall be final & binding on the bidders. The Civil Hospital shall not entertain any claim on the basis of cost incurred by the Bidders for preparation of the Bid.
10. The envelope of the “Financial Bid Document” of post qualified bidders will be opened in the presence of their representative at a time to be determined.
