### NOTICE FOR INVITING TENDERS


The Culture Department, Government of Sindh, invites sealed tenders on prescribed Tender forms for the ADP - Scheme No. 1413 - "Printing of Ganj Sharif" from the reputed, experienced, eligible and financially sound printing firms and companies.

*Note: This tender is intended to reprint the existing Ganj Sharif. Therefore, all designs, colors and other specs should at least match the quality of the existing Ganj Sharif. Any improvement in the quality would be welcomed. As such, a copy of the existing Ganj Sharif is available in the office of Director General, Culture Department, and the same may be seen before tendering the bids.*

### TERMS AND CONDITIONS

1. The intending participants can purchase up to 28-12-2011 the set of tender documents (containing Technical specifications and other details) from the office of Director General, Culture Department, Block 76, Sindh Secretariat, Opposite M.P.A. Hostel, Karachi against payment of tender fee Rs.2,000/- (Non-refundable) for each tender in shape of Pay Order in the name of Director General, Culture Department, Government of Sindh, from the date of publication of tender.
2. Tenders shall be received back on 29-12-2011, up to 12:00 Noon and be opened on the same date at 02:00 p.m. in the presence of Printing & Publication Committee and Procurement Committee and participating bidder(s) or their authorized representatives, if they wish to attend.
3. Eligibility conditions are as per Sindh PPRA Rules, 2010, for tender participants which are as under:-
  - a) Proven experience of accomplishing such a high quality printing books works and certificate of satisfactory completion of such works. At least 03 different published books (printed in 05 or 06 colors) must be submitted.
  - b) Only those firms will be considered eligible to participate in the tender, who have their own printing press. The Printing & Publication Committee and Procurement Committee may require the bidder to produce documentary evidence in this regard.

- c) Registration with Income Tax Department (NTN) Certificate.
  - d) Registration with Sales Tax Department (GST) Certificate.
  - e) Undertaking on affidavit that the firm is not involved in any litigation or has not abandoned any work in any department.
  - f) Provide company's / firm's Bank Statement.
4. The bidders should submit earnest money @ 2% of the bid amount, in shape of call deposit/pay order/demand draft prepared from the scheduled bank in favour of Secretary, Culture Department, Government of Sindh, Karachi.
  5. It is categorically mentioned that conditional bids / tenders will not be accepted.
  6. As per Sindh PPRA (2010) Rule 46(2) bidders are required to submit "Technical" & "Financial" Proposal separately in clearly marked envelopes mentioning, "Technical Proposal" and "Financial Proposal" in bold and legible letters to avoid confusion. Initially only the envelope marked "Technical Proposal" shall be opened. "Financial Proposal" of only those bidders will be considered / opened, whose "Technical Proposal" is qualified / accepted by the Printing & Publication Committee and Procurement Committee.
  7. The financial Proposals will be opened on the same date after finalizing the names of bidders whose Technical Proposal is qualified / accepted by the Printing & Publication Committee and Procurement Committee.
  8. Affidavit to the effect that all documents/particulars/information furnished is true and correct is also required.
  9. The Printing & Publication Committee and Procurement Committee reserve the right to accept or reject any bid / tender without assigning any reason.
  10. The successful bidder shall enter into an agreement (on Stamp Paper) with the Culture Department that the work will be completed in accordance with the Sindh PPRA (2010) Rule No. 18.
  11. SPPRA Rules will be strictly observed.
