- f) Details of works amounting to Rs. 10.00 (M) or more in the above mentioned fields completed in 05 years giving full information as to client/consultants, project location, scope of work, total cost, original time and the time when completed together with performance certificate.
- g) List of works in hand along with cost, names and addresses of client and consultants.
- h) Details of machinery, plant & equipments owned by the company/ contractor/firm with proof.
- i) List of permanent technical staff, their qualifications and experience along with CVs and PEC registration.
- j) An affidavit on non judicial stamp paper that the firm has never been blacklisted by the department.
- k) Details of arbitration or litigation if any.
- l) Registration of Income Tax Department with NTN No.
- m) Any other information in support of prequalification application.
- n) Affidavit on non judicial stamp paper that all documents/particulars/information furnished in connection with the prequalification application or true.
