Both Envelopes (Technical and Financial) should be sealed separately and placed in a 3rd Envelope. The name of the bidder be clearly marked on all envelopes.
2. The Tender Documents will only be issued to those Company / Manufacturers who have the valid Registration with Sales Tax, Income Tax, proof of which will be provided alongwith the request letter for issuance of Tender Documents.
3. A complete set of tender documents can be purchased from the date of publication in newspapers during working hours up to **03-10-2011**, (3.00pm) on submission of a written application with non-refundable fee as mentioned above in shape of pay order/ bank draft in favour of Director Fisheries Sindh Marine Karachi.

The Tenders in sealed envelope mentioning the name of work should be dropped in the Tender Box in the Office of Director of Fisheries Sindh Marine Karachi up to **04-10-2011** up to **1:00 pm** Only Technical offers shall be opened first on same day at **2:00 P.M.** in the presence of Bidders or their Authorized Representatives. The Financial offer will be kept in safe custody and will be opened of those bidders only who qualify; un-qualified bidder's offer will be returned unopened.
5. Rates should be quoted on F. O. R. Sindh basis.

6. Cutting or overwriting in the Tender must be avoided, in case there is any should be completely rewritten, duly signed and stamped.
7. The Tender No. and Date of opening should be mentioned on the envelope. Tender received after specified time and date will not be considered.
8. Preference will be given to those parties having their Manufacturing Facilities in Sindh with after Sales Services Network and supplies in Interior of Sindh.
