- Bidders must have registration with all the tax authorities.
- Bids should be attached call deposit/ pay order of 2.5% of bid security.
- Bidders having relevant experience in the same assignment at least three years
- Bid must be quoted in Pak Rupees.
- Bid must be supported with relevant literature, country of origin make, brand (along with technical literature)

Terms & Conditions.

- (a) Under following conditions bid will be rejected:-
- (i) Bids not accompanied by bid security of required amount and form;
 - (ii) Bids received after specified date and time.
 - (iii) Black listed firms.

- (c) Health certificate from the exporting country, health certificate from Animal Quarantine Department Karachi should be accompanied with the consignment Deputy Director (HQ) Directorate of Animal Breeding will check & collect the consignment at Airport / Seaport Karachi.
- (d) Delivery will be at Red Sindhi Cattle Breeding farm Tando Muhammad Khan farm.
- (e) The Director Animal Breeding Sindh Hyderabad / Procurement Committee of Livestock wing reserves the rights to reject all or any bids subject to the relevant provisions of SPPRA rules 2010 (as amended).
- (f) The firm must be payer of income tax having income tax registration number.
- (g) The firm must have GST payers.
