Interested Manufacturers /Suppliers and authorized dealers may obtain the tender document along with detail of repair work to be undertaken on the above Equipment (item wise) from Mr. Muhammad Ejaz Khan, Assistant of SSP/Security Office, Special Branch Arambagh Police Complex, Karachi Cell No. 0333-3450152 & Office Contact No. 021-99212672 by submitting an application on their letter head along with Tender Fee of Rs. 1000/- from 11-03-2018 to 26-03-2018.
3. The interested Bidders may inspect the item to be repaired at the BD Store, Special Branch, Aram Bagh Police Complex. The X-Ray Baggage Scanning Machine may be inspected at site installed in Larkana. Due assistance will be provided in this regard.
4. Sealed tenders on prescribed Proforma in duplicate along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/c in favor of SSP/Security Special Branch Karachi should be dropped in the tender box kept in the office of the SSP/Security Special Branch Arambagh Police Complex, Karachi 27.03.2018 at 1400 hours.

5. The tenders shall be opened on 27.03.2018 at 1500 hours in presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion in the Committee in the office of the SSP/Security Special Branch Arambagh Police Complex, Karachi.
6. Only Manufacturers / Suppliers and authorized dealers registered with Income Tax Department are eligible to participate in the tenders (Documentary proof required)
7. Only bid offered on the prescribed tender form issued by the Special Branch, Police Department accepted. However, additional sheets may be attached, if required.
