Sealed Tenders are invited on emergency basis from intending participants for Transportation of ATTA of Ramzan Package & Other Misc: Work for the period ending 28th Feb: 2010 (Year 2009-10) in case of other Misc: work & upto the end of the month of Holly Ramzan in case transportation of Atta pertaining to Ramzan package, by (Registered Post / Courier Service only) in the prescribed tender form obtainable from this office on the payment of Rs: 2,000/- (Rupees Two Thousand only) per tender form (non refundable) up to 09-09-2009, so as to reach up to 10-09-2009 at 12.00 Noon in the Office of the Deputy Director Food, Hyderabad Region, Room NO: 109 Block A, Ground Floor Shahbaz Building Hyderabad, which will be opened on the same day i.e. 10-09-2009 at 12-30 P.M., in presence of the parties or their representative, who wish to be present. *

No tender form shall be issued on the day of opening of the tenders.

For tendering the rates, following terms and condition may also be fulfilled and required to attach following documents / certificate with the application

1. The parties should fill in tender form for all the Districts.
2. The Parties will have to furnish a personal Surety Bond on Judicial / Stamp Paper of Rs.500/- for other, district (within region) including the Bolhari/Kotri Rs:10.00 Million and within district Rs:5.00 Million with concerned District Food Controller of this Region. In case of contract will be awarded.
3. Each tender should be accompanied by Security Deposit/ Earnest Money in the form of CDR pledged to the Deputy Director Food, Hyderabad Region which will be attached with application for purchase of tender.
4. The rates should be quoted in the words as well as in figures. Incomplete and conditional offers shall be liable to rejection.
5. The Tenders received after due date and time will not be entertained.
6. The other terms and conditions, the details of work, the amount of security deposit are shown in the statement attached to the Tender Form are available in the Regional Office, Hyderabad.
7. The envelope should invariably bear the words "TENDERS".
8. The bidder who wish to under take the work also have to attach with the application an statement of his Bank account for last two years during the financial year showing at least one transaction of Rs:10 .000 (Million) Financial Stability Certificate obtain from schedule Bank and Income Tax Certificate issued by Income Tax Department.
9. That the transporter shall have sufficient experience of the work.
10. Character certificate from Station House Officer (SHO) of concerned Police Station to the effect that the applicant is not involved in any criminal / defalcation case.
11. That if the transporter is a firm a Registration Certificate with the concerned Government Department shall also be provided, with details of the names of the partners and their postal addresses (Permanent as well as present).
12. That a list of the trucks if owned by the transporter shall be furnished with photocopy of documents showing ownership of Trucks.
13. That correct official residential address, alongwith telephone No: attested photocopy of Identity Card shall be provided.
14. That certificate from the Nazim of the area shall be furnished to the effect that the applicant is neither a Government servant nor a student and nor a convict.
