- ii) Each bag shall bear the following indelible ink.
- iii) a. **“SINDH FOOD 2012.”**
b. **NAME OF MANUFACTURER / SUPPLIER.**
 - (i) Manufacturers, traders as well as importers are allowed to participate in the tenders.
 - (ii) The trader shall produce authenticated proof of source of supply alongwith tender and relevant papers thereof.
 - (iii) Bidders are allowed to offer any quantity.
 - (iv) Bidding Document is available from the Office of **Section Officer (W), Food Department, Government of Sindh, Karachi** and could be obtained against paid Challan of Rs.2000.00 per set in State Bank of Pakistan (Non- Refundable) from the date of this publication during office hours.
- (v) The bidders are required to submit earnest money @ 2.5% of the amount of their offer in the shape of Pay order in favour of Secretary Food, Government of Sindh. Tenders not supported by earnest money will not be entertained.
- (vi) The quantity can be increased or decreased as per SPPRA Rules 2010 without assigning any reason.
- (vii) The successful bidder in addition to the bid security shall submit security deposit in shape of Pay Order in favour of Secretary Food Sindh to the tune of 2.5% of value of Contract in accordance with SPPRA Rules-2010.
- (viii) The bidders are required to follow the Sales Tax Act and relevant SROs.

- (ix) Last date for submission of tender is 08-02-2012 up to 1.00 p.m. **The tender will be opened on the same day at 2.00 p.m. in the Office of Secretary Food, Government of Sindh, New Sindh Secretariat Building No. 1, 4th Floor, Karachi** in the presence of bidders or their representatives. If 08-02-2012 is declared public holiday/ general riot, then tender will be received/opened on next working day at same time and venue.
- (x) In case NITs remain un-responded by the above date the next date of opening will be 11-02-2012 and if again the NITs remain un-responded the next date of opening will be 14-02-2012. Time and venue will remain same.
- (xi) No tender form will be issued on the day of opening of tender.
- (xii) The importer will quote their rates on delivered at consignee end in local currency. List of Consignees is attached with bidding document.
- (xiii) The execution of the agreement shall be the responsibility of the successful bidder(s) within three days.
- (xiv) The agreement so executed shall be the binding document for both the parties.
- (xv) Prices quoted shall be inclusive of all taxes, duties including Octroi, Sales Tax etc up to Consignees end.
- (xvi) The evaluation of bid shall be on single stage two envelop procedure in concurrence with SPPRA-2010 (Details is given in bidding document)
- (xvii) The bidders shall submit separately, Financial and Technical proposals alongwith offer.
- (xviii) The offers shall be firm, unambiguous and unconditional.
- (xix) The successful Bidder shall be liable to affix adhesive stamp on the agreement at Rs 0.3% of the value of the Contract.
- (xx) The Bidder shall be required to provide two samples of the product duly sealed and signed along with their offer.
- (xxi) In case of failure on the part of the parties to perform their obligations under the contract will not be considered a default if such failure is the result of an event of force majeure as defined in the conditions of contract as per Clause-40 of SPPRA Rules-2010.
- (xxii) The purchaser reserves the right to reject any or all of the offers as per provision of SPPRA Rules-2010.
