- ii) Each bag shall bear the following indelible ink.
- iii) a. "SINDH FOOD 2010"  
b. NAME OF MANUFACTURER / SUPPLIER.
  - (i) Manufacturers, Traders as well as Importers are allowed to participate in the Tenders.
  - (ii) The Bidder shall produce authenticated proof of source of supply alongwith Tender and relevant papers thereof.
  - (iii) Bidders are allowed to offer any quantity.
  - (iv) Bidding document is available from the Office of **Section Officer (W), Food Department, Government of Sindh, Karachi** and could be obtained against paid Challans of Rs.2000.00 per set in Government Treasury / State Bank of Pakistan (Non-Refundable) during office hours.
  - (v) The Bidders are required to submit bid security @ 2.5% of the amount of their offer in the shape of Pay order in favour of Secretary Food, Government of Sindh. Tenders not supported by bid security will not be entertained.
  - (vi) The quantity can be increased or decreased upto 15% of the quantity as per clause (42) of SPPRA Rules.

- (vii) The successful Bidder in addition to the bid security shall submit security deposit in shape of Pay Order or Bank Guarantee valid upto 3 (Three) months or after completion of Contract in favour of Secretary Food Sindh to the tune of 2.5% of value of Contract.
- (viii) The Bidders are required / follow the Clause of Sales Tax special procedure (withholding) Rules 2007 vide SRO-660 (1) 2007 dated 30.6.2007.
- (ix) Last date for submission of Tender is 12-01-2010 up to 1.30 p.m. **The Tender will be opened on the same day ( Technical Proposals at 2.00 pm & Financial proposal at 3.30 p.m.) in the Office of Secretary Food, Government of Sindh, New Sindh Secretariat Building No. 1, 4<sup>th</sup> Floor, Karachi** in the presence of Bidders or their representatives who wished to be present.
- (x) No Tender form will be issued on the day of opening of Tender.
- (xi) The Importer will quote their rates on delivered at Consignee end in local currency. List of Consignees is attached with bidding document.
- (xii) Prices quoted shall be inclusive of all taxes, duties including Octroi, Sales Tax etc up to Consignees end.
- (xiii) The evaluation of bid shall be on single stage two envelop procedure of SPPRA- 2004. (Details is given in bidding document)
- (xiv) They shall submit separately, Financial and Technical proposals alongwith offer.
- (xv) The offers shall be firm, unambiguous and unconditional.
- (xvi) The successful Bidder shall be liable to affix adhesive stamp on the agreement at Rs 0.3% of the value of the Contract.
- (xvii) The Bidder should be registered with the Sale Tax Department and should enclose a copy of the Registration along with Tender.
- (xviii) The Bidder shall be required to provide two samples of the product duly sealed and signed along with their offer.
- (xix) The purchaser reserves the right to reject any or all of the offers as per provision of SPPRA Rrules.
