Sealed Tenders are invited on emergency basis from intending participants for Transportation of Wheat for seed purpose & Miscellaneous work etc from Within Districts / Other District (Within Region) for the period ending **28th February 2012** (Year 2011-12) by (Registered Post / Courier Service only) in the prescribed form obtainable from this office upto **24-12-2011** at Rs: 2,000/- (Rupees Two Thousand only) per form (non refundable) which should reach upto **26-12-2011** at **02.00 P.M.** in the Office of the Deputy Director Food, Hyderabad Region, Room NO: 109 Block A, Ground Floor Shahbaz Building Hyderabad Region, which will be opened on the same day i.e, on **26-12-2011** at **02-30 P.M.**, in presence of the parties or their representative, who wish to be present.

No tender form shall be issued on the day of opening of the tenders.

For tendering the rates, following terms and conditions may also be fulfilled and required to attach following documents/certificate with the application.

1. The parties should fill in tender form for each District separately.
2. The Parties will have to furnish a personal Surety Bond on Judicial/Stamp Paper of Rs.500/- for Other Region Rs. 20.000 Million, other district (within region) including the Bolhari/Kotri Rs:10.00 Million and within district Rs:5.00 Million with concerned District Food Controller of this Region. In case of contract will be awarded.
3. Each tender should be accompanied by Security Deposit/ Earnest Money in the form of CDR pledged to the Deputy Director Food, Hyderabad Region.
4. The rates should be quoted in the words as well as in figures. Incomplete and conditional offers shall be liable to rejection.
5. The Tender received after due date and time will not be entertained.
6. The other terms and conditions, details of work and amount of security deposit are shown in the statement attached to the Tender Form, which can be obtain from this Regional Directorate.
7. The envelope should invariably bear the words "**TENDERS**".
8. The bidder who wish to under take the work also have to attach with the application an statement of his Bank account for last two financial years showing at least one transaction of Rs:10 .000 (Million) Financial Stability Certificate obtained from schedule Bank and Income Tax Certificate issued by Income Tax Department.
9. That the transporter shall have sufficient experience of the work.
10. Character certificate from Station House Officer (SHO)-of concerned Police Station to the effect that the applicant is not involved in any criminal / defalcation case.
11. That the bidders shall submit their bids in a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. The first envelope shall be marked as "**Technical Proposal**" & second as "**Financial Proposal**" in bold & legible letter to avoid confusion under the relevant provision of Rule 46 (2) of SPP Rules, 2010.
